Transferring securities is very easy to do. Simply follow these directions:

1. Complete the attached form (you may need your broker's assistance) and deliver it to your broker or financial advisor with regard to your wish to make a gift of securities to Prostate Cancer Foundation BC.
2. Your broker should contact and deliver the form and the securities to our agent, Gianni Tessarolo

3. Once the securities have been transferred to the Foundation's brokerage account, Scotiatrust will advise us in writing of the receipt of the securities and the closing bid value on the day the securities were received into our account.
4. We will issue an official receipt to you, for income tax purposes, for the value as determined by Scotiatrust.
5. It is the Foundation's policy that securities, once received by the Foundation or its broker, may be sold or added in specie to the Foundation's investment account in accordance with the Foundation's investment policies.
